



Wyoming's Tomorrow Scholarship At-A-Glance Summary

Scholarship Purpose – Wyoming's Tomorrow Scholarship (WTS) endowment is intended to provide post-secondary education access through financial assistance to qualified students. Dividends from the endowment create (A) annual base allocations of scholarship awards issued to the College and (B) a high demand allocation to represent secondary, statewide allocation to support scholarship awards to students in high growth/high demand academic programs identified by the Wyoming Community College Commission (WCCC). In the 2024 legislative session, the WY Legislature appropriated sufficient funds to bring the WTS corpus to the required \$50M threshold to permit scholarships from its dividend. WTS scholarships (funded from the dividend) will begin in the 2025-26 award year.

During the 2024 legislative biennium session, \$2,500,000 in one-time funds were appropriated by the WY Legislature to be awarded to otherwise eligible students using Wyoming's Tomorrow Scholarship statute, rules, and guidance, but under a different scholarship name. For the 2024-25 & 2025-26 award years (combined), these one-time funds are known as Kickstart Wyoming's Tomorrow Scholarships (KWTS).

All other student eligibility and administrative requirements will remain the same under both scholarship programs.

On 1.8.25, WCCC's Executive Director Ben Moritz clarified that:

- Attempting more than 12.0 credits during a semester does not accelerate a student's consumption of KWTS/WTS aggregate eligibility. Attempting more than 12.0 credits during a semester counts as the equivalent of only a single full-time semester of KWTS/WTS usage deducted from the "equivalent of four (4) full time academic terms" ([WY 2022 HB0031](#)) of KWTS/WTS aggregate eligibility. This 1/8/25 WCCC (Ben Moritz) adjusted interpretation of eligibility definitions supersedes the WCCC (Michael Swank) email circulated December 2024.
- A student who receives KWTS may be eligible for WTS if the student has not exhausted the aggregate KWTS eligibility of the "equivalent of four FT semesters or a total of seven thousand two hundred dollars (\$7,200.00) in scholarships for unmet financial need" ([WY 2022 HB0031](#)) of awards. A student may not receive both KWTS & WTS awards in any given semester and may not receive more awards than "equivalent of four FT semesters or a total of seven thousand two hundred dollars (\$7,200.00) in scholarships for unmet financial need" in combined KWTS/WTS receipts. Eligible Programs – Two types of programs are eligible for KWTS/WTS Scholarships:

1. All for-credit programs (Certificates, Associates, Bachelors)
2. Select non-credit programs which have been previously approved for Wyoming Works Student Grants (WWSG). Approved WWSG programs are:

Scholarship Awards – An otherwise eligible student may not receive KWTS/WTS after receiving the "equivalent of four full time semesters" (for those students who elect to enroll less than full time, the "equivalent of four full time semesters" equates to 48.0 total credits for which KWTS/WTS is awarded.) Award amounts are \$150.00/credit hour, up to a maximum FT enrollment semester award of \$1,800.00 per semester, even if more than 12.0 credits are attempted during that semester. Students in eligible non-credit programs are considered to be the equivalent of full-time enrolled, are not prorated for enrollment status, and may not receive more than \$1,800.00 for any period of academic engagement that is substantially

equal to, or less than, an academic semester in length. Award amounts are determined through calculation of a student's federal need:

- Cost of Attendance (COA)
- Student Aid Index (SAI)
- All Gift Aid*
- = Need

**With the exception of a Wyoming Works Student Grant (WWSG) which is a last-dollar award as specified in statute. So, if a student is eligible for both KWTS/WTS and Wyoming Works, KWTS/WTS awards are determined first, then WWSG awards are determined. Otherwise, KWTS/WTS is considered to be the last-dollar award calculated for the student.*

Important Award Distinction – An eligible student may not receive KWTS/WTS after receiving a maximum of 48.0 credits worth of KWTS/WTS awards. With guidance from the Wyoming Community College Commission, this means:

- If a student enrolls and completes four full-time semesters at less than the maximum of \$1,800 per semester due to award reduction due to limited Need calculation, KWTS/WTS eligibility is exhausted. Statute provides no flexibility in the number of full-time terms for which the scholarship applies. The \$7,200 maximum scholarship amount available only applies to those that are deemed eligible for the maximum semester allotment every full-time term for which a student is enrolled.
- Students who do not attend full time during a semester have KWTS/WTS awards calculated by registered semester credit at \$150.00/credit. A part-time student could attend more than four terms and receive a fraction of their eligible full-time award each term, but once they receive 48.0 semester credit hours of KWTS/WTS awards (the equivalent to four full-time semesters), their eligibility terminates.

Scholarship Awarding Priority – Funding for the KWTS/WTS programs that span more than one year is subject to the availability of funds and is contingent on the State Treasurer transferring monies to the KWTS/WTS account. In the event that annual scholarship budgets are insufficient to meet demand, the WCCC and the College may prioritize awards to qualified applicants in the following order:

- Students who receive a scholarship in the immediately preceding term,
- Students with an industry sponsorship,
- Students entering a program of study determined to be a high need or economic growth or economic development opportunity area determined by the Commission.
- Students who have not previously obtained a postsecondary credential.
- All other applicants.

Funding for the KWTS/WTS programs that span more than one year is subject to the availability of funds as provided by the Wyoming's Tomorrow Scholarship Endowment and is contingent on the State Treasurer transferring monies to the Wyoming's Tomorrow Scholarship Expenditure account. Any scholarship awarded by NWC is provisional until certified by the Wyoming Community College Commission and certification is not guaranteed.

Student Eligibility – Students must meet all eligibility requirements (initial or renewal) to receive a KWTS/WTS Scholarship:

1. Be a US Citizen or an eligible non-Citizen who meets the definition of eligible non-citizen under federal Title IV requirements.
2. Be at least 24 years of age by the commencement of the semester where KWTS/WTS Scholarship is applicable.

3. Be a Wyoming resident and have been for at least one full calendar year prior to submitting this application.
4. Complete an annual Free Application for Federal Student Aid (FAFSA), have a valid Student Aid Index (SAI), and have federal need, as calculated by the Financial Aid Office.
5. Not be receiving a Hathaway Scholarship for the period of enrollment where the KWTS/WTS Scholarship is applied.
6. Agree to register, or have previously registered, for any available training assistance program with the Wyoming Dept. of Workforce Services, as required by the Wyoming's Tomorrow Scholarship program's statute. A student who does not check the "yes" box to both DWS requirements is ineligible for KWTS/WTS. A student may contact DWS at wyomingatwork.com. 7. Not owe a refund under federal Title IV student financial aid programs or a subsequently enacted federal student financial aid program, or a student financial aid program administered through the state.
8. Not be incarcerated.
9. Apply prior to the commencement of the semester for which the KWTS/WTS Scholarship is desired.
10. Meet Satisfactory Academic Progress requirements:
 - a. For-Credit programs:
 - i. Maintain a cumulative Grade Point Average (GPA) of at least 2.0 for each semester; and
 - ii. Successfully complete at least two-thirds of all attempted credits each semester.
 - b. Eligible Non-Credit programs: successfully complete the non-credit program.
11. ~~Once a KWTS/WTS disbursement is received, maintain continuous enrollment for not less than two academic terms in each successive academic year.~~ The continuous enrollment requirement was rescinded by law under [2026 HB0025](#) effective 7.1.26. This means that:
 - a. Awards made for the Summer 2026 semester, regardless of the date of award or application, are awarded under the 2025-26 eligibility requirements which still contain the continuous enrollment requirement.
 - b. Awards made for the 2026-27 award year forward (beginning with the Fall 2026 semester) do not have the continuous enrollment requirement.
12. Have not received KWTS/WTS in the amount "equivalent to four full time semesters", regardless of total KWTS/WTS amounts received (i.e. even if less than \$7,200 was disbursed due to award reduction due to limited Need calculation) – see *Scholarship Awards* section above for more info about these calculations. A student's eligibility for a scholarship shall permanently terminate once the student has reached this awarded credit limit.
13. Students who transfer from one college to another may maintain Wyoming's Tomorrow Scholarships, provided the student has not reached the maximum allowable limit of KWTS/WTS Scholarship receipts as specified in the *Scholarship Awards* section.
14. Students who graduate from, or otherwise complete, a program may be eligible to receive scholarships if enrolled in a subsequent, next (meaning "sequential"), or higher level (meaning credential ascension) program, as long as:
 - a. The student is not reenrolled in, or otherwise re-attempting, the previously completed program; and
 - b. The student continues to meet all eligibility requirements; and
 - c. The student has not previously received the aggregate amount of scholarship authorized

~~**Appeals (after Loss of Eligibility)** – The Wyoming's Tomorrow Scholarship statute permits appeal for failing to maintain continuous enrollment. The Wyoming Community College Commission will make available to any student who has lost the scholarship due to a lapse in enrollment an appeal process to be considered for scholarship reinstatement. Processes are clearly articulated on the Commission website and include a waiver application. The College shall refer any interested individual to the Commission.~~

Continuous enrollment requirement was rescinded by law under [2026 HB0025](#), effective 7.1.26. This means that, for all awards made under the 2026-27 award year forward (beginning with the Fall 2026 semester), there are no appeal options for Wyoming's Tomorrow Scholarship.

Repeated Courses/Content – A student required to repeat coursework or program content within a program due to failure, withdrawal, or lapse in enrollment (if reinstated through approved Commission appeal) may receive additional student scholarships for future payment periods in future semesters of enrollment for the repeated coursework or program content, subject to the maximum scholarship amount provided in law.

Consortium Agreements – Students are permitted to receive KWTS/WTS Scholarships for approved courses taken in combination with HOME/HOST school enrollment. Students shall apply for KWTS/WTS with the student's HOME college's financial aid office at any time prior to the beginning of their next semester of enrollment. NWC students wishing to use a KWTS/WTS consortium agreement at NWC shall use the College's Federal Student Aid Consortium Agreement form & procedure.
